

**“105.1 The BOUNCE “Girls Night out Double Play” Contest
OFFICIAL CONTEST RULES**

These rules apply to the 105.1 The BOUNCE “Girls Night out Double Play” Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WMGC-FM (“Station”). **In addition, the General Contest Rules posted at www.1051thebounce.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on Monday, February 19, 2024 and end on Friday, March 8, 2024.
- b. To participate in the Contest, listen to the Station each weekday beginning on Monday, February 19, 2024 and ending on Friday, March 8, 2024 between the hours of 8:00am Eastern Time (“ET”) and 5:00pm ET for two (2) songs back-to-back from either Nicki Minaj, Monica, Nelly, or Janet Jackson (the “Double Play”). When you hear the beginning of the second song of the Double Play begin to air, text the keyword “**GIRLS**” to **248-544-1051**. Message and data rates may be charged by your wireless carrier. The Station is not responsible for any fees incurred by you for this method of entry. Text message and any mobile device entries will be deemed made by the authorized account holder of the mobile account submitted at the time of entry. The authorized account holder is the natural person who is assigned to the text or mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. By initiating a text message to the Station in this Contest, you also expressly consent to the receipt of a reply message confirming your entry and notification via text if you are selected to be a winner.
- c. **Only one (1) entry per person per Double Play is permitted. Multiple entrants are not permitted to share the same telephone number. Entrants are not permitted to use multiple telephone numbers.** The deadline to enter is ten (10) minutes after the second song of the Double Play begins to air. Any text message entries received after ten (10) minutes past the second song of the Double Play begins to air or any text message entries with the incorrect Keyword will be disqualified.
- d. There will be up to a total of three (3) winners selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in the Detroit Metro Area, consisting of

the following Michigan counties: Lenawee, Monroe, Wayne, Washtenaw, Jackson, Hillsdale, Ingham, Livingston, Oakland, Macomb, St. Clair, Lapeer, Genesee, and Shiawassee; and the following Ohio Counties: Lucas, Fulton, and Williams except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to three (3) prizes will be awarded in this Contest. Each prize consists of: (i) one (1) one hundred dollar (\$100) gift certificate to Woodhouse Spa, 1447 Woodward Ave, Detroit MI 48226; (ii) four (4) tickets to see Nicki Minaj on April 20, 2024 at Little Caesars Arena, 2645 Woodward Ave Detroit MI 48201; (iii) four (4) tickets to Janet Jackson with Nelly on July 2, 2024 at Pine Knob Music Theatre 33 Bob Seger Dr. Clarkston, MI 48348; and (iv) four (4) tickets to Wanda Sykes at The Fillmore Detroit on May 17, 2024, 2115 Woodward Ave, Detroit, MI 48201. Approximate Retail Value (“ARV”) of each prize is \$1,411.

The gift card will be subject to the terms and conditions as set forth by the issuer of the gift card. Gift cards are not refundable or transferable and may not be substituted or exchanged for cash or credit at any time, nor will gift cards be replaced if lost or stolen.

The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). The prize(s) is awarded as is. Tickets valid only on the date(s) printed on the tickets. Tickets are not refundable or transferable, and may not be substituted or exchanged for cash or credit at any time, nor will tickets be replaced if lost or stolen. Tickets may not be sold to a third party. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond control of the Station and/or prize provider, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded element(s) of the prize(s). The Station and/or venue, in their sole discretion, reserve the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior, does not follow Station and/or venue policy regarding COVID-19 guidelines, or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize-related event. Winner understands that there are inherent risks involved in attending the prize-related event.

 - ii. Up to one (1) winner will be selected at approximately 6:00pm ET on Friday, March 1, 2024 in a Station-conducted random drawing from all combined eligible text message entries received the week of February 26, 2024 through March 1, 2024.
 - iii. Up to one (1) winner will be selected at approximately 6:00pm ET on Friday, March 8, 2024 in a Station-conducted random drawing from all combined eligible text message entries received the week of March 4, 2024 through March 8, 2024.
 - iv. Non-winning entries will **not** automatically rollover into any subsequent random drawings. Potential winners will be notified by telephone promptly following the random drawings.
- b. Odds of winning depend on the number of eligible text entries received for each respective random drawing.
- c. Entrants must listen to the Station to enter but need not be present to enter and win.
- d. Each winner must confirm acceptance of prize within seventy-two (72) hours of winning, or risk disqualification and selection of an alternate winner (time permitting) in a random drawing of all remaining eligible entries from that respective random drawing.
- e. Decisions of Station management with respect to the Contest are final.
